N Laguna Creek Wetlands - 40 adults, 16 children. 30 bags filled. Filled a City Parks trash trailer. ~500 pounds.

Bufferlands - 38 adults, 40 children. 110 bags filled. 7 tires.. Leather armchair, igloo dog house. 9,000 pounds.

There had been other clean-ups earlier on the CSD Helping Hands service day. We may want to do our clean-up the same day next year and get the benefit of the CSD advertising.

Report on Bird Box Assembly and Laguna Creek Exploration

12 people (4 children) All participants were actively involved. Two bird boxes were given away to families attending. Five new boxes were installed on posts that the City had placed for the purpose. Steve explained to the group that because the forest here is new, there are no large trees with cavities for cavity nesters such as bluebirds to use.
